# INSTRUCTIONS TO CANDIDATES FOR FILLING IN THE ONLINE APPLICATION FORM FOR INDIAN ECONOMIC SERVICE/INDIAN STATISTICAL SERVICE EXAMINATION, 2025

#### 'Important'

THE COMMISSION HAS IMPLEMENTED A NEW REGISTRATION AND ONLINE APPLICATION FORM FOR THE INDIAN ECONOMIC SERVICE/ INDIAN STATISTICAL SERVICE EXAMINATION, 2025. CANDIDATES ARE REQUESTED TO NOTE THAT THEY ARE REQUIRED TO UPLOAD ALL THE REQUISITE DETAILS AND DOCUMENTS INCLUDING MATRICULATION CERTIFICATE, EDUCATIONAL CERTIFICATES, COMMUNITIY/PWBD CERTIFICATE (IF APPLICABLE), NECESSARY UNDERTAKINGS (WHEREVER APPLICABLE) IN REGISTRATION AND ONLINE APPLICATION FORM WHICH SHALL REMAIN OPEN FORM 12<sup>TH</sup> FEBRUARY 2025 TO 04<sup>TH</sup> MARCH 2025.

Applicants for the Indian Economic Service/ Indian Statistical Service Examination, 2025, must upload all required documents during this application window. To avoid last minute rush and complications, candidates are encouraged to have their required certificates ready and submit their applications well in advance.

#### FACILITATION COUNTER FOR HELPLINE FOR GUIDANCE OF CANDIDATES:

In case of any guidance/information/clarification regarding their applications, candidature etc. candidates can contact UPSC's Facilitation Counter near gate 'C' of its campus in person or over Telephone No. 011-23385271/011-23381125/011-23098543 on working days between 10:00 hrs and 17:00 hrs.

- 1. Applicants are advised to carefully go through the detailed Notice No. 07/2025-IES/ISS, which can be viewed on the website of the Commission (<a href="https://upsc.gov.in/">https://upsc.gov.in/</a>) as well as the website <a href="https://upsconline.gov.in">https://upsc.gov.in/</a>).
- 2. All the candidates are advised that before filling up the Online Application Form (OAF) for the Indian Economic Service/ Indian Statistical Service Examination, 2025, they must register themselves through **ONE TIME REGISTRATION (OTR)** using the URL <a href="https://www.upsconline.gov.in">https://www.upsconline.gov.in</a>.
- 3. Before applying for the IES / ISS Examination 2025, the candidates are requested to check their eligibility (w.r.t. minimum educational qualification, age etc.) given in the Notice of the Examination, available on Commission's website.
- 4. Candidate should have details of one Photo ID Card viz. Aadhaar Card / Voter Card (EPIC)/ PAN Card / Passport / Driving License / Any other Photo ID Card issued by the State / Central Government. The details of this Photo ID will be used for all future

- references and the candidate is advised to carry this Photo ID Card while appearing for the Examination/Personality Test.
- 5. The candidates who are required to pay the examination fee must ensure that the fee is paid by them. The examination fees once paid will not be refunded under any circumstances. It may also be noted that fee once paid for one application is not allowed to be adjusted against another application.
- 6. While filling in his/her Application Form, the candidate should carefully decide about his/her choice of centre for the Examination. If any candidate appears at a centre other than the one indicated by the Commission in his/her e-Admit Card, the papers of such a candidate will not be evaluated and his/her candidature will liable to cancellation.
- 7. Suitable provisions for information regarding use of scribes by the Candidates (PwBD/PwD) who are eligible to avail the facility of scribe (as prescribed in the Rules) have been made in the OAF at the time of the initial OAF itself.
- 8. Applicants are requested to note that before filling the OAF they may have a careful look on the common reasons where an applicant's online application is being rejected by the Commission. Applicants are therefore advised to be careful enough so that chances of their applications being rejected are minimized to the best possible extent and their effort is not lost due to the reasons which can be avoided by them if they remain slightly more careful while submitting their application to the Commission.
- 9. The Experience of Commission (UPSC) shows that major rejection happens due to the following reasons.
  - a) Application being rejected on the grounds of bad quality of submitted photograph.
  - b) Application being rejected on the grounds of bad quality of submitted signature.
  - c) Application being rejected on the grounds of swapping of photograph with that of signature.
  - d) Application rejected due to submission of photograph only, i.e. no signature submitted or photograph submitted at the place of signature as well.
  - e) Application rejected due to submission of signature only, i.e. no photograph submitted or signature submitted at the place of photograph as well.
  - f) Applicant have filled all the details in OAF but failed to finally submit the OAF before the closing date.
  - g) Fee Payment details against one application has been submitted to another application ID (Fee once paid against one application, is not allowed to be adjusted against another application\*).
  - h) Application being rejected on the grounds of non-submission of payment proof to the Commission within specified time in case of fictitious payment. [Fictitious payment cases are those cases for which the Commission does not receive any information from the bank authorities to which the applicant has claimed to have deposited his/her fees.]

- \*cases (which are intimated to the applicant through e-mail as well as published on the website of the Commission within 2 weeks after the last date of receipt of online application).
- 10. Candidates applying online need NOT send hard copy of the OAF filled by them online or any other document / certificate / testimonial to the Union Public Service Commission. However, they are advised to take printout of the OAF and retain it for further communication with the Commission.
- 11. The Candidates applying for the examination should ensure that they fulfill all eligibility conditions for admission to examination. Their admission at all the stages of the examination will be purely provisional subject to satisfying the prescribed eligibility conditions.
- 12. Mere issue of admission certificate to the candidate will not imply that his candidature has been finally cleared by the Commission. The Commission takes up verification of eligibility conditions with reference to original documents at subsequent stages of examination process.
- 13. Online Application process must be completed before 18:00 hours of 04<sup>th</sup> March, 2025.
- 14. In the interest of coordinated and secured logistics, the Commission may not operate Centres where the number of candidates is very low. In such cases, the Commission may allot nearest Centres to the candidates. THE DECISION OF THE COMMISSION IN THIS REGARD WILL BE FINAL AND NO FURTHER CORRESPONDENCE WILL BE ENTERTAINED FROM CANDIDATES.
- 15. The Centres and the dates of holding the Examination as mentioned above are liable to be changed at the discretion of the Commission. While every effort will be made to allot the candidate to the Centre of his choice, the Commission may, at their discretion allot a different Centre or a new Centre that may be opened when circumstances so warrant.
- 16. No request for withdrawal of candidature received from a candidate after he / she has submitted his/her application will be entertained.
- 17. The e-admit cards will be uploaded in the Commission's website. The candidates should download the same and check it carefully to ensure that the particulars on the e-Admit Card are correct. In case, there is any mistake in the e-Admit Card, it should be brought to the notice of the Commission with a request to issue the correct e-Admit Card. Candidates may note that they will not be allowed to take the examination on the strength of e-Admit Card issued in respect of another candidate. No candidate will be allowed to take the examination without the e-admit card.
- 18. Persons in Government service whether in a permanent or temporary capacity or as work charged employees other than casual or daily rated employees or those serving under Public Enterprises are required to **upload** an undertaking (**Annexure-I**) that they have informed in writing their Head of Office/ Department that they have applied for the Examination. Candidates should note that in case a communication is received from their employer by the Commission withholding permission to the candidates applying for/appearing at the Examination, their applications will be liable to be

rejected/candidature will be liable to be cancelled. (Please refer Rule 9 of the Indian Economic Service/Indian Statistical Service Examination Rules, 2025).

- 19. A candidate appearing in the examination should also bring with him/ her to the examination hall extra copies of the photograph similar to the one uploaded in the application form, as per the instructions given in the e-Admit Card.
- 20. A candidate who claims to belong to one of the Schedule Castes, the Schedule Tribes or the Other Backward Classes should upload in support of his/her claim a scanned copy of the certificate in the form given in Appendix-I from the District Officer or the Sub-Divisional Officer or any other officer of the district in which his/her parents (or surviving parent) ordinarily reside. Such an officer should have been designated by the State Government concerned as competent to issue such a certificate. If both his/her parents are dead, the officer signing the certificate should be of the district in which the candidate himself/herself ordinarily resides otherwise than for the purpose of his/her own education.
  - 20.1 A candidate who claims reservation benefit under Economically Weaker Section (EWS) should <u>upload</u> in support of his/her claim a scanned copy of the Income and Asset Certificate based on the income of Financial Year (FY) 2023-24 (Certificate of Eligibility) in the form given in Appendix-V.
  - Note 1: Candidates should note that their SC/ST/PwBD/Ex-servicemen certificate should have been issued latest by the closing date of application for Indian Economic Service/ Indian Statistical Service Examination, 2025 [i.e. 04.03.2025] as prescribed in the Rule 21 of the Rules for the Examination.
  - Note 2: EWS Category candidates should note that 'Income and Asset Certificate' must be issued in prescribed format based on the income for Financial Year 2023-24 (i.e. for the period 1<sup>st</sup> April, 2023 to 31<sup>st</sup> March, 2024) in support of their claim. Certificate based on the income of any other Financial Year shall not be treated as valid. The Certificate must be issued on/after 01.04.2024 (after the completion of FY 2023-24) but not later than the closing date of the application for Indian Economic Service/Indian Statistical Service Examination, 2025 i.e. 04.03.2025. Such candidates must meet the Income and Asset criteria issued by the Central Government.
  - Note 3: The OBC category candidates should note that the OBC (Non-Creamy Layer) certificate must be in prescribed format based on the income for the Financial Years (FYs) 2023-24, 2022-23 and 2021-22. The Certificate must be issued on/after 01.04.2024 (after the completion of FY 2023-24) but not later than the closing date of the application for Indian Economic Service/Indian Statistical Service Examination- 2025 i.e. 04.03.2025. Candidates should also note that the name of their caste (including its spellings) as indicated in their certificates, should be exactly the same as published in the lists notified by the Central Government from time to time. A certificate containing any variation in the caste name will not be accepted.
  - **Note 4 :** The OBC/SC/ST claim of a candidate will be determined in relation to the State (or part of the State) to which his/her father originally belongs. A candidate who has migrated from one State (or part of the State) to another should, therefore, produce an OBC/SC/ST certificate which should have been issued to him based on his

father's OBC/SC/ST certificate from the State to which he (father) originally belongs.

- **Note 5 :** No change in the community status indicated by a candidate in his/her application form for the Indian Economic Service/Indian Statistical Service Examination will be allowed by the Commission except in the circumstances mentioned in the Rule 20 of the Indian Economic Service/Indian Statistical Service Examination Rules, 2025.
- 21. A candidate disabled while in the Defence Services claiming age concession should upload a scanned copy of the certificate in the form given in **Appendix-II**, from the Director General Resettlement, Ministry of Defence to show that he/she was disabled while in the Defence Services in operations during hostilities with any foreign country or in a disturbed area and released as a consequence thereof.
  - 21.1 Ex-servicemen including Commissioned Officers and ECOs/SSCOs claiming age concession should upload a scanned copy of the certificate as applicable to them, in the form given in **Appendix-III**, from the authorities concerned.
- 22. A candidate claiming to belong to Persons with Benchmark Disability category shall be required to meet one or more of the physical requirement/abilities, as laid down in Rule 19 of the Rules for the Indian Economic Service/Indian Statistical Service Examination, 2025. He/She must upload a scanned copy of the Certificate of Disability in Form V/Form VI/Form VII/others issued by notified Medical Authority of the Central/ State Government. Such Disability Certificate should have been issued latest by the closing date of submission of online application form for Indian Economic Service/ Indian Statistical Service, 2025 (i.e. 04.03.2025) as prescribed in Rule 21 of the Rules of the Examination.
  - NOTE: NOTWITHSTANDING THE AFORESAID PROVISION FOR AGE RELAXATION, A CANDIDATE BELONGING TO PERSONS WITH BENCHMARK DISABILITY CATEGORY WILL BE CONSIDERED TO BE ELIGIBLE FOR APPOINTMENT ONLY IF HE/SHE (AFTER SUCH PHYSICAL EXAMINATION AS THE GOVERNMENT OR THE APPOINTING AUTHORITY, AS THE CASE MAY BE, MAY PRESCRIBE) IS FOUND TO SATISFY THE REQUIREMENTS OF PHYSICAL AND MEDICAL STANDARDS FOR THE INDIAN ECONOMIC SERVICE/INDIAN STATISTICAL SERVICE TO CANDIDATES BELONGING TO THE PERSONS WITH BENCHMARK DISABILITY CATEGORY BY THE GOVERNMENT.
- 23. In all communications with the Commission regarding his/her Online Application Form (OAF), the candidate should mention the name of the Examination, his/her Full Name, Roll Number and his/her Date of birth.
- 24. A candidate must see that communication sent to him at the address stated in his OAF is redirected, if necessary. Any change in address should be communicated to the Commission at the earliest opportunity. Although the Commission makes every effort to take account of such changes, they cannot accept any responsibility in the matter.
- 25. The candidates should note that their candidature for the Indian Economic Service/ Indian Statistical Service Examination, 2025 will be purely provisional, subject to their satisfying the prescribed eligibility conditions. If on verification at any stage

before or after the examination it is found that they do not fulfill any of the eligibility conditions, their candidature for the examination will be cancelled by the Commission.

- 26. The candidate should also scan their relevant original documents as listed below and it should be uploaded along with the Online submission of Application Form.
  - (I) Scanned Copy of Matriculation Certification/School Leaving Certificate as proof of date of birth or any other certificate/document as prescribed Rule 6(a) of the Rules for the exam.
  - (II) Scanned copy of certificates showing his/her educational qualification prescribed in para 3(iii) of the Notice of the Examination uploaded on the website of Commission and Rule 7 of the Rules of Examination published in the Gazette of India dated 12<sup>th</sup> February, 2025.
  - (III) Scanned copy of certificate in support of claim to belong to Scheduled Castes/Scheduled Tribes/Other Backward Classes/EWS and <u>UNDERTAKING</u>
    FOR OBC/EWS CANDIDATES, as applicable. The original physical copy of UNDERTAKING must be submitted at the time of Personality Test.
  - (IV) Scanned Copy of an Undertaking duly signed by the candidate seeking relaxation as OBC candidate in support of claim of not belonging to creamy layer, to be given in format as mentioned in para B-1 of Appendix-I.
  - (V) OBC and EWS Annexure to be filled up online by OBC and EWS candidates.
  - (VI) Scanned copy of certificate in support of claim of age concession, wherever applicable.
  - (VII) Scanned copy of certificate(s) in support of claim to being Persons with Benchmark Disability (wherever applicable).
  - (VIII) Scanned Copy of certificate(s) to the effect that person concerned has limitation to write in support of claim.
  - (IX) Scanned Copy of an undertaking duly signed by the candidates if already in Government service. The original physical copy must be submitted at the time of Personality Test.
  - (X) Copy of the selected Photo ID Proof (viz. Aadhaar Card, Voter Card, PAN Card, Passport, Driving Licence or any other Photo ID Proof issued by the Central/State Government.)
- 27. Duly signed copy of the Online Application Form along with originals of the above certificates are required to be produced along with self certified copies of all the documents at the time of interview or within the last day of interview, which will be published in the Commission's Website in due course, failing which their candidature is liable to be cancelled. It may also be noted that in no case the last date of verification of certificates will be extended. Candidate must also note that they should upload only the scanned copies of the original documents and no document is required to be sent by post.
- 28. A candidate must upload along with his/her Online Application Form, a scanned copy of certificate of age (indicating his/her date of birth). The date of birth accepted by the Commission is that entered in the Matriculation or Secondary School Leaving Certificate or in a certificate recognised by an Indian University as equivalent to Matriculation or in an extract from a Register of Matriculates maintained by a University which extract must be certified by the proper authority of the University. A candidate who has passed the Higher Secondary Examination or an equivalent

Examination may upload a scanned copy of the Higher Secondary Examination certificate or an equivalent certificate.

No other document relating to age like horoscopes, affidavits, birth extracts from Municipal Corporation, Service Records and the like, will be accepted.

The expression Matriculation/Higher Secondary Examination Certificate in this part of the instructions includes the alternative certificate mentioned above.

Sometimes the Matriculation/Higher Secondary Examination Certificate does not show the date of birth or only shows the age by completed years or completed years and months. In such cases a candidate must upload in addition to the Matriculation/Higher Secondary Examination Certificate a scanned copy of the certificate from the Headmaster/ Principal of the Institution from where he/she passed the Matriculation/Higher Secondary Examination showing date of his/her birth or his/her exact age as recorded in the Admission Register of the Institution.

- 29. A candidate must upload a scanned copy of a certificate showing his educational qualification prescribed in para 3(III) of the Notice dated 12<sup>th</sup> February, 2025 for the Examinations available on the website of Commission. The uploaded certificate must be the one issued by the Competent Authority (i.e. University or other examining body) awarding the particular qualification.
  - **Note-1:** A candidate who holds a completed secondary school certificate need to upload a scanned copy of the page containing entries relating to age only.
  - **Note-2:** Candidates should note that only the date of birth as recorded in the matriculation/ higher secondary examination certificate or an equivalent certificate on the date of submission of application will be accepted by the Commission and no subsequent request for its change will be considered or granted.

Candidates are warned that unless complete proof of age as laid down in these instructions is sent with the application, the candidature of the candidate will be rejected.

- 30. Candidates are advised to read carefully the Rules of the Examination, which include conditions of eligibility etc. as published in the Gazette of India dated 12<sup>th</sup> February, 2025. They should, therefore, take special care to fill up the application form correctly. In case there are any illegible or misleading entries, the candidates will be responsible for the consequences thereof.
- 31. The candidates should note that their candidature for the Indian Economic Service/ Indian Statistical Service Examination, 2025 will be purely provisional, subject to their satisfying the prescribed eligibility conditions. If on verification at any stage before or after the examination it is found that they do not fulfill any of the eligibility conditions, their candidature for the examination will be cancelled by the Commission.

**Note**: Candidates shortlisted for interview on the basis of written result will be required to upload scanned copies of documents/relevant certificates in support of claims made in the on-line application as and when demanded by the Commission.

Originals of the above certificates are required to be produced at the time of interview along with a set of self certified documents.

- 32. Any Online Application Form received without scanned copies of all or some of the enclosures will entail cancellation of candidature. Any missing enclosures sent subsequently by the candidate will not be entertained. The candidates must ensure that the Application Form is properly filled in through online.
- 33. In case of further doubts, if any, the candidate may refer to FAQ available on the website <a href="https://upsc.gov.in/">https://upsc.gov.in/</a>

NOTE: CANDIDATES QUALIFIED FOR INTERVIEW FOR THE PERSONALITY TEST ON THE RESULTS OF THE WRITTEN PART OF THE EXAMINATION WILL BE REQUIRED TO PRODUCE THE ORIGINALS OF THE REQUISITE CERTIFICATES. FAILURE TO SUBMIT THE REQUIRED CERTIFICATES IN ORIGINAL AT THAT TIME WILL ENTAIL CANCELLATION OF CANDIDATURE.
